Falcon Regional Park - Phase 2 Expansion

Work is in full swing out at Falcon Regional Park. The goal of the project is increase organized opportunities and build off-of the initial improvements constructed in Phase I completed in 2015. The project includes construction of an additional baseball field, construction of a multiuse field, asphalt paving of the existing parking lot, construction of an overflow gravel parking lot, and various site grading and flatwork. The overall project budget is \$955,000 and includes funding from a Great Outdoors Colorado grant, El Paso County regional park fees, and third-party fundraising. Construction is scheduled to completed by end of May 2021.

Is your "honey do" list about to erupt because the of the warm weather pending?

Here are some helpful ideas to add to the list from the DRC:

Does your front yard meet all the minimum requirements? Did your shrubs not make it over the winter? If so, please refer to Section 5.2 in DRC no 1 or Section 6.2 in DRC no 2 for the minimum number of shrubs and trees for the front yard. The minimum number is always required to be maintained with live vegetation. Take advantage of good inventory at the nurseries by checking now!

How does your solid fence look? Did the winter months give the wood a beating and now it looks weathered? The standard for the Meridian Ranch community is to maintain fences in like new condition. The color for the fences is "Meridian Ranch Brown" Behr semi-transparent wood stain, produce #3077 or premium semi-transparent wood stain, weather proofing, product #5077, redwood natural tone, color, available at Home Depot on Woodmen Road and Powers Blvd.

Did the wind and grapple take advantage of the siding and trim of your home? Don't forget that all improvements must be submitted and approved prior to application. Please submit the color of the body, the trim, and the accent colors of the home. Please contact the Management Team to review colors that were approved for your builder ahead of time, so your home will be in compliance with the approved color schemes prior to the submittal.

These ideas should help keep your property looking pristine while keeping Meridian Ranch a beautiful place to live! We thank all of our residents for doing their part, without you, Meridian Ranch would not be the desirable place or destination new residents want to call home!

The Board of Directors acted on clarifying and amending a section of the Design Guidelines which pertains to lighting. This will assist with the under-eave lighting which can't be seen as it is installed under the eve of the home: Section 7.3 Landscape lighting: "Lighting design should take into account the effect on neighboring homes, preventing light spillage onto adjacent properties. Floodlights for the purpose of lighting large areas shall not be permitted except security purposes with limited use as where approved by the DRC. Colored or multiple lights other than seasonal decorative lights installed from November 15th to January 15th are prohibited."

In order to clarify colored, multiple lights as well as newly installed professionally under eve lighting, the following verbiage has been added:

"Under eave packages will be allowed with the following provisions. Installed per manufacturers specifications. The physical lights, conduit and associated hardware shall be hidden from view when not in use. Display of lighting is allowed before 10:00 p.m. After 10:00 p.m. exempt during the holiday season, subtle low level neutral lighting will be allowed in accordance with the first paragraph of this quideline. The use of colored lighting for holidays throughout the year shall be subtle and turned of after 10:00 p.m."

Manager's Message ◊ April 2021

Don't Turn Those Sprinklers on yet!


More than half the water used between May and October is for landscape irrigation.

Based on community water-use figure, 40% to 50% of landscape irrigation water is wasted! This is often due to poor irrigation system design, maintenance, and management – and the fact that past irrigation system design seldom focused on water conservation.

With irrigation season rapidly approaching, we respectfully ask for your help conserving water resources. Please wait to activate your sprinkler system until as late into the season as possible depending on the weather.

April is the perfect time to turn on your automatic sprinkler system and run each zone through a test cycle. Check for leaks or damaged and misaligned sprinkler heads. If you see runoff, reposition, or replace the sprinkler heads to water only the grass. But please do not set your system to cycle automatically until at least mid-May.

Research shows that postponing irrigation systems start up encourages grass roots to seek water and grow deeper. When hot, dry summer days arrive, a deeper root system means the grass can go longer between watering's. Regular irrigation that begins too early in the season can result in the death of deep roots, making lawns less drought and wear tolerant.





For deep roots like this, post-pone irrigation until mid-May!

It's about that time!



Spring has sprung! Chances are you have already been considering improvements you would like to make to the exterior of your home. We are excited to provide you with what you need in order to apply for the changes you would like to make.

You may have some questions about the process:

Do I have to submit a plan for approval?

Yes! If it is outside your home, but within your Lot, chances are you need to submit a plan. Additional information on what does or doesn't need to be submitted for are in the governing documents which you may access on the website.

How can I make sure I get a determination as soon as possible?

- If you fill out the application, provide a drawing or birds eye view (showing placement of changes), and include as much information as possible (nature, kind, shape, height, width, color, materials).
- Submit a plan that already complies with the Design Guidelines. It is very important that each homeowner at Stonebridge review the Stonebridge CC&Rs and Design Guidelines prior to designing and installing landscaping or making additions or changing the exterior of the home.

How much does it cost to submit a plan?

Stonebridge residents must submit a landscape plan prior to installing their initial landscaping. A \$50.00 fee will be charged for design reviews. Checks made out to Stonebridge HOA.

How do I get the application?

- Your welcome packet. When you moved in you received a welcome packet that also had the Site Improvement Application included.
- The website. When you go to https://stonebridgemeridian.nabrnetwork.com you will find the form under RESOURCES and then GOVERNING DOCUMENTS (so you can review what is permitted before you submit).



- Through the WMG to GO app. When you sign into the app, you will find the form under RESOURCES and then GOVERNING DOCUMENTS.
- The Lodge Estelle has a few applications on hand.

After the application has been filled out, you may send it to us via email at

stonebridge@warrenmgmt.com, drop it off at our office, or mail it to us. If you are unable to scan your application, you may take a picture of the form, the drawing of your Lot with the details and then email it to us.


